GENERAL RULES & REGULATIONS KENYU-RYU KARATE

GENERAL RULES & REGULATIONS

- All practitioners must follow the KENYU-RYU Karate syllabus and grading structure.
- Students and instructors must adhere to discipline, respect, and dojo etiquette.
- Instructors must conduct training as per the official KENYU-RYU Karate standards.

AFFILIATION & RENEWAL REQUIREMENTS

- Every club must renew its affiliation every year before 31st December. Affiliation Fee:
 - ₹2000 INR per club (to be paid annually).
- Affiliation renewal must be done through the KENYU-RYU Headquarters.

MANDATORY PURCHASE OF BELTS & CERTIFICATES

- Every instructor must buy color belt and certificate directly from the KENYU-RYU Headquarters.
- Unauthorized belt distribution or certification without headquarters' approval is strictly prohibited..

MANDATORY USE OF KENYU-RYU LOGO ON UNIFORMS

- The KenYu-Ryu official logo must be worn on all karate uniforms (Gi).
- The logo must be placed on the left side of the chest as per official KENYU-RYU standards.
- Only official KENYU-RYU logos supplied by headquarters are allowed—unauthorized logos are strictly prohibited.

UNAUTHORIZED USE OF KENYU-RYU NAME & LOGO

- Without official affiliation or permission from the National Headquarters, the use of the KENYU-RYU name, logo, or branding is strictly prohibited.
- Any unauthorized use will result in legal action against the individual or organization involved.
- Clubs or instructors found violating this rule will face:
 - Immediate disqualification from KENYU-RYU events and programs.
 - Legal proceedings as per trademark and intellectual property laws.
 - Permanent ban from affiliation with KENYU-RYU Karate.

GRADING TEST & CAMP NOTIFICATION

- All grading test dates and karate camps must be reported in advance to the headquarters.
- Instructors must submit a request for grading tests at least 30 days before the scheduled date.
- Only approved examiners from the headquarters can conduct grading tests.

MANDATORY TRAINING CAMPS FOR INSTRUCTORS & BLACK BELTS

KENYU-RYU Headquarters conducts mandatory training camps twice a year, in:

- May
- December

All instructors and black belts must attend these camps to maintain their certification and stay updated with the latest techniques and syllabus

CHIEF INSTRUCTORS' RESPONSIBILITY FOR SEMINARS

- All KENYU-RYU Chief Instructors must arrange training camps in their own locations to develop students and instructors in their region.
- The Shibuchō of KENYU-RYU must be invited to these camps to ensure proper guidance and quality training.
- The schedule and details of these camps must be submitted to the headquarters in advance for approval.

INSTRUCTOR CERTIFICATION & ELIGIBILITY

- Only certified instructors recognized by the KENYU-RYU Headquarters can teach.
 - Pass the Instructor Certification Program conducted by headquarters.
 - Maintain an active membership and affiliation renewal every year before 31st December.

INSTRUCTOR RESPONSIBILITIES

- Ensure all students follow the KENYU-RYU syllabus and maintain high discipline.
- Promote ethics, respect, and traditional karate values in training.
- Provide regular training and encourage students to participate in tournaments and seminars.
- Maintain proper student records, grading history, and attendance.

NEW RULES FOR DISTRICT & STATE ASSOCIATIONS – CHAMPIONSHIP FEE & CERTIFICATION

- All District and State KENYU-RYU Karate Associations must pay ₹100 INR per participant for every championship they conduct, including:
 - District Championship
 - State Championship
 - School or Club Championships
- This fee must be paid to the National Headquarters before the event.
- Certificates for all participants will be provided by the National Federation after the payment is confirmed.
